Course Description

Linear equations and matrices; real vector spaces, linear transformations, change of bases, determinants, eigenvalues and eigenvectors, diagonalization, inner products.

Course Prerequisites

MATH148, **MATH152** or **MATH172**; **MATH300**; junior or senior classification or approval of instructor, honors eligibility.

Course Learning Outcomes

This course will familiarize students with both (hand) computational methods (matrices, row reduction, Gaussian elimination) and abstract methods (vector spaces, linear transformations) for solving and studying linear systems of equations. Students will gain an appreciation for the power of the abstract methods. They will further develop their ability to read, write, and understand proofs.

Linear Algebra by Leon/de Pillis, 10th edition

Grading Policy

There will be 2 exams during the semester, and a final exam. There will also be graded homework. The weights will be: homework 25%, Exam 1 20%, Exam 2 20%, and Final Exam 35%.
